Champaign County Local Emergency Planning Committee (LEPC)
Annual Report 2012

The Champaign County Local Emergency Planning Committee (LEPC) was organized to fulfill the requirements of the federal regulations regarding Title III of the Superfund Amendment and Reauthorization Act (SARA) of 1986 and to address the public safety concerns of industry and the community regarding hazardous materials. The LEPC is the local body that handles emergency planning and community right-to-know reporting on hazardous and toxic chemicals.

The Champaign County LEPC is comprised of 26 members from County and City Departments, industry representatives, and community members. Within Champaign County there are 147 Tier II facilities, including 61 extreme hazard facilities. Champaign County LEPC documents to include reports, facility information, and hazard information are under the supervision of the Champaign County Emergency Management Agency.

The enclosed Annual Report has been developed to provide LEPC members, County Commissioners, and the citizens of Champaign County with a status update on the progress of the LEPC during the year 2012. The LEPC members look forward to an even more productive year in 2013, one in which community, business, industry, government and the citizenry can all benefit from an evolving partnership in hazardous materials safety.

MISSION STATEMENT

The LEPC shall exist to serve as a community forum for issues relating to preparedness for emergencies involving hazardous substances within Champaign County.

PURPOSE AND FUNCTION

The functions and duties of the LEPC are those outlined by the Illinois Emergency Management Agency, in accordance with, but not necessarily limited to the provisions of Title III of the Superfund Amendments and Reauthorization Act of 1986. More specifically the LEPC shall engage in at least the following activities:

1. Conduct regular meetings to address all pertinent issues
2. Maintain a county-wide master inventory of hazardous materials regulated by State and Federal governments as regulated by SARA Title III.
3. Develop and update a Hazardous Material Emergency Response Plan as defined by SARA Title III, Section 303[42 U.S.C. 11003] Comprehensive Emergency Response Plans.
4. Identify private/public sector resources available to assist with hazardous material emergencies.
5. Review, process and respond to public requests of information.
6. Review, maintain and process all appropriate reports and records, as required by law.
7. Provide information on training programs related to hazardous material safety and emergency response procedures.
8. Coordinate emergency response exercises.
9. Provide expertise and assistance to industries and business upon request.
10. Provide community “out-reach” services on all hazards safety.
11. Research and disseminate emerging legislation relating to hazardous.

It is not and never has been the intent of the LEPC to be a local regulatory, enforcement, permitting, or policy making body or agency. Further, the LEPC shall not be placed in a position to interfere with the permitting process of the State of Illinois.

EXECUTIVE COMMITTEE

Executive Committee (Elected Officers) - The executive committee will comprise of the Chairperson, Vice-Chairperson, and Secretary; nominated and elected by members of the LEPC.

2012 ACCOMPLISHMENTS

Throughout the 2012 year, the LEPC membership continued to grow and reestablish itself as a viable, functioning committee meeting quarterly. In January of 2012, IEMA awarded Champaign County Emergency Management Agency with the Hazardous Materials Emergency Preparedness Grant for the 2012 year. The grant would service to provide funding for the LEPC. During the first quarterly meeting of 2012, Kathy Allen, Manager of the Hazardous Materials Section for the Illinois Emergency management Agency gave a presentation to the new LEPC as to the functions and purpose of local emergency planning committees. At the May 7, 2012 meeting, the executive committee was elected with John Dwyer serving as Chairperson, Todd Hitt as Vice-Chairperson, and Jamie Davis completing the executive committee in the position of Secretary. At the June 26, 2012 meeting, the LEPC committee voted to approve the proposed by-laws.

Training and learning opportunities were made available to all committee members throughout the year. All committee members were required to complete the Open Meetings Act training as required by State law. Classes on the Computer-Aided Management Emergency Operations (CAMEO) were offered and completed by four LEPC members. At the June 5, 2012 quarterly meeting, representatives from Illini FS presented an overview of the Illini FS exercise. Multiple committee members attended the IEMA conference in September of 2012. During the September 2012 meeting, LEPC members were given a tour of the Champaign County Hazardous Materials Response facility and equipment. In December 2012, Chris Miller of the National Weather Service spoke to the committee regarding plume modeling, and Lieutenant John Barker of the Champaign Fire Department lead a discussion on the County's Highway Closure Plan.

2013 GOALS

The LEPC looks forward to continuing on its path of growth, community safety and community outreach in the 2013 year. The Champaign County Emergency Management Agency will be submitting the HEMP Grant reapplication in July of 2013 to obtain funding to support the mission of the LEPC. It is the goal of the committee that during the 2013 year, it will continue to hold regular quarterly meetings and create subcommittees, as deemed appropriate by the committee. The LEPC will continue to offer training and learning opportunities for the LEPC members, including attending the IEMA conference in September.

It is the goal of the LEPC that it will be able to begin creation of site specific plans, integrate CAMEO into emergency management planning, and to begin the process of conducting a commodity flow study within the county, and to identify further training opportunities that would be beneficial to members of the LEPC. Further, the LEPC will continue to strive to fulfill its mission to serve as a community forum for issues relating to preparedness for emergencies involving hazardous substances within Champaign County.

Approval of minutes from June 26, 2012 meeting

Minutes were approved by the group.

Computer-Aided Management Emergency Operations (CAMEO) class update

A CAMEO (Computer-Aided Management of Emergency Operations) class was set-up in September. It is three programs that work together; you can enter tier II data and run scenarios with the systems. The class was 4-5 hours and 5 people attended the class. CAMEO and associated programs have been installed on multiple computers in the EOC and on laptops for emergency use. It doesn't interface with current fire department software. Oklahoma uses it to track tornado damage. We hope to have the full day class in the future.

Discussion of 2011-2012 Hazardous Materials Emergency Planning (HMEP) Grant & 2012-2013 Hazardous Materials Emergency Planning (HMEP) Grant

Funding for the 2012-2013 (HMEP) grant will be similar to the previous year. The grant was submitted on July 6th to IEMA. It will fund conferences and training: IEMA conference, Midwest Hazardous Materials Conference, the IESMA conference, Midwest Emergency Preparedness and Response and Conference. We may look at a commodity flow study in 2013 or 2014 of hazardous materials via highway and rail.

Discussion of Recent Changes to EPRC (Emergency Planning and Community Right-To-Know Act and LEPC Update from the Illinois Emergency Management Agency Conference

Slides from the IEMA conference were handed out. Things to note: IL is an IDOL state. There was discussion on who should report. There are new storage range codes. IL is an OSHA state by code. There is a reminder that the LEPC is a public body, please complete the Open Meetings Act. Also, the Global Harmonization System was discussed by Pat Titus from Ilini FS. It seems as if industry is moving quicker than the response agencies on the subject.

Open Discussion

April 2013 there will be a full-scale exercise with the National Guard in Rantoul with a hazmat scenario. We will have a guest speaker from the National Weather Service next meeting to discuss their ability to assist with a hazmat spill. Also, Todd Hitt asked if there was any direction the committee wanted to take to make this a more functional LEPC. And finally, if interested in the conferences please let the committee know.

Chairperson John Dwyer called the meeting to order at 10:35 am.

Approval of minutes from September 25, 2012 meeting

Minutes were approved by the group.

Presentation by Chris Miller from the National Weather Service (NWS), Lincoln, IL

Chris Miller from the NWS out of Lincoln briefed attendees about their HYSPLIT model. This model can forecast large scale, hazardous materials plumes and dispersion. This model can give emergency managers and incident commanders needed assistance in making critical public safety decisions, such as sheltering in place or evacuations. This system complements the Aloha software emergency management has. Aloha only does plumes for a 60 minute duration whereas HYSPLIT can go for hours. Emergency Management can call the NWS to run a HYSPLIT model for an incident.

Discussion of Highway Closure Plan by Captain John Barker of Champaign Fire Department

Captain John Barker discussed the area interstate highway closure plan for incidents that could be hazardous materials related or traffic incidents. Secondary accidents can be overwhelming. This plans let cities and jurisdiction know how traffic will be routed according the location of the incident on the highway. This plan is in line with the University of Illinois and Parkland College evacuation plans. The plan will be implemented by April 1, 2013.

Discussion of 2012-2013 Hazardous Materials Emergency Planning (HMEP) Grant

Opportunities for conference attendance was discussed to include the 2013 Midwest Hazardous Materials Response Conference, May 3, 4 2013 in Northbrook, IL and the Midwest Emergency Preparedness & Response Conference, Rockford, Illinois, May 1-3, 2013
